AQUABIKE SUPERLICENCES FOR 2007 SEASON

Dear Sirs,

Please find hereafter the updated 2007 rule regarding the application for the aquabike superlicences. The updated application procedure is also posted on our website under forms and procedures.

Rule 203.02.01

Superlicences will be issued through the UIM Secretariat only. The pilot must have a valid licence delivered by a National Authority recognized by the UIM and following the UIM activities in aquabike racing.

Superlicence criteria :

- Four national races or international ordinary races
- Sports CV with official results
- To provide a valid attestation of Civil Responsibility insurance in and out race for a minimum amount of 1.000.000 Euro and with the exception of coverage of the pilots and their aquabike amongst drivers
- **The World Superlicence or the Continental superlicence is to be requested 4 weeks before the first event with a photograph and payment of fee**

The holder of a World Superlicence or Continental Superlicence cannot be refused by the organising National Authority except in case of serious fault during the season.

- Daily Licence “for World Championship” 50 Euro**
 - Daily Pass “for Continental Championship” 25 Euro**
- The daily licence and the daily Pass are valid for one race only and cannot be deducted when a World or Continental Superlicence is taken.**

The drivers should add their photograph on the daily licences and the passes for recognition by the officials.


Any drivers which do not have a photograph, should have their photo taken at the race site by the official photographer which will transmit to the UIM for the Superlicence database.

Since the first race on the Aquabike calendar is scheduled in Guadeloupe on March 21, 2007, we ask all the participants to urgently provide us with all required documents.
